

California Regional Promotion Blueprint:

A Practical Plan to Build a 60,000-person Private Domain Member Network

A referral link and a small meeting room can also create a new Web3 business opportunity with an annual income of millions

Development logic and operation process

Each F2C California agent already has his own exclusive referral link. As long as you continue to develop with this link

With merchants and members, your business system can automatically expand and fission, and form a stable source of income.

### ÿStep 1: Create your "M1 Merchant Node Account"

1. Use your agent referral link to register a new account (this account will be given to the merchant you want to cooperate with in the future). for home use).

2. Name this account "M1" and obtain its referral link.

3. Use M1's referral link to invite new people to register as F2C members (please refer to the "F2C Member Registration Guide").

Tip: F2C will deliver targeted ads based on your city or zip code through social media such as Facebook and Instagram , allowing local people to register directly using your M1 link, helping you automatically expand your community.

#### ÿStep 2: When the number of M1 members reaches 2,000, this is your "business asset"

- When the M1 account has more than 2,000 members, you can resell or lease M1 to a local merchant (merchants who understand Web3 and F2C mechanisms will see the value).
- The price is determined by you. This is your private membership asset, which has tradability and continuous profit potential. force.

### ÿStep 3: Repeat the process to create M2, M3, M4, M4...M30...

- Continue to create more node accounts (M2 ~ M30) with your proxy account, and each account will independently develop a group of member.
- When you have completed 30 accounts, each account will have an average of 2,000 members, and the total will have 60,000 private members. Domain user network.

According to the average referral reward model and GC incentive estimates, such a system is enough for you to earn millions of dollars a year
potential for earnings.

# Offline positions of regional agents: Build your F2C local base

As a regional agent, you not only need to expand membership and node accounts online, but also need a base for physical gatherings.

• It is recommended to prepare at least one meeting room that can accommodate about 30 people as:

• Weekly F2C new employee briefing venue

• Business training and promotion tool teaching space

• A community base for members to gather and learn from each other

This will not only make you a "F2C knowledge center", but will also win you more community trust and support from physical merchants.

## Final summary:

A node account is an operating unit; a local community is

a channel to multiply your income; when you have 30 nodes, it is equivalent to

operating 30 digital franchise stores at the same time. You are no longer an agent, but a leader in California's

Web3 private domain economy.

Each regional agent must set up a Telegram group (which can accommodate up to 200,000 people). Once these members have recognized you, you can ask

them to download a Telegram chat tool and Telegram group. At the same time, follow the public account (Telegram) of the F2C system. The news and notifications of the F2C system will be posted on it.

## Build a local membership community: Telegram group is your core asset

In the F2C system, each regional agent must establish his or her own Telegram group, which is the main venue for you to maintain relationships with members and release value.

ÿWhy choose Telegram?

- Can accommodate up to 200,000 users
- Support robot automated management, announcement push, voice live broadcast, chat room grouping

• It is the preferred social platform for global Web3 projects, and cryptocurrency users are highly active

Operation process suggestions:

1. Create a Telegram group in advance (naming suggestion: "F2C California Area Code Member Group")

- 2. When the number of members reaches a certain scale (for example, more than 500 people), start guiding them to join the Telegram group
- 3. Explain to members: The Telegram group will be the only official channel to receive F2C system activities, bonus notifications, recommended skills teaching, and announcements
- 4. Ask new members to complete the following tasks immediately:
  - Download Telegram App
  - Join the regional group you created
  - Follow the official channel of F2C system (Telegram public account)

Warm reminder speech example (available for agents to send group announcements):

Dear members, our regional membership has exceeded 500 ! In order to more conveniently

notify system rewards, appreciation information and new activities, we will transfer all management to

Telegram group! Please click the

following link to join our Telegram group [your Telegram group link]

Please follow the official channel

simultaneously: F2C Global Official Notification Account (@F2C\_Official)

All first-hand reward policies, merchant launches, and GC market announcements will be released there.

### Ultimate goal:

This Telegram group is not just a notification tool, it is your "membership sovereignty community" for the Web3 regional economy:

• In the future, you can hold teaching sessions, AMA live broadcasts, and motivational activities in the group

• This is the starting point of your private domain fission and the asset library of your regional brand

When these 200,000 people are in your group and recognize you, you will be the Web3 consumer economy center of this area.
